Important Dates to Remember

Completed monthly P-Card reconciliation packages are due in Accounts Payable OJN-320 on the 15th business day of the following month.

NOTE: The reconciliation deadline for April 2019 charges is tentatively May 21. The actual final due date will be communicated in the Year End Memo. P-Card holders will receive a separate email confirming the deadline date for April and prior transactions. The P-Card holder is responsible for sharing these dates with their proxy/delegates.
